DTPC invites proposals for the service provider to provide facilities maintenance services for Dube TradePort for a period of three (3) years.

These services will include, but not limited to:

- Continuous inspection of all DTPC building facilities to determine the state of the facilities and assess maintenance requirements comprehensively.
- Any defects noted above will be discussed with DTPC for remedial actions;
- To propose to DTPC a preventative maintenance plan, schedule and to review these on an annual basis or as required by DTPC Property Operations. Further highlighting the types of maintenance below:
  - o Scheduled Condition Based Maintenance of equipment;
  - Scheduled Maintenance:
  - o Corrective Maintenance; and
  - o Statutory Maintenance.

#### **EVALUATION OF THIS BID**

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The 20 preference points will be allocated to the following as included in the bid document:

- 15 points allocated to Enterprises (bidders) who are at least 51% or more owned by Black People; AND
- II. 5 points allocated to Enterprises (bidders) who are located within in KwaZulu-Natal.
